# **New Business/Communications**

## **1. Future Meeting Dates**

Discussion ensued on the possibility of adding a meeting in June, in order to get organized for the following school year. The board agreed to add a June meeting on Wednesday, June 10th at 6pm.

## 2. Fruit Sale

The fruit sale started on Friday, October 4th. Here is a link to the <u>Online Store</u>. If people buy online, they need to choose which student they are buying it for, because there are incentives if students sell so many items.

The Board opted to go with the 30% profit for the fruit in order to sell more fruit since it will be cheaper. The prices online are correct, but the brochure is wrong, showing the 40% profit. The prices in the brochure are higher than they will actually be.

**Volunteer Planning** for Delivery Day - parents are needed to organize unloading and separating, since pickup is allowed from 1-5pm. The Ag teacher has approved us using their space for this, even though they are not participating this year.

The only issue might be how the money is handled for the silent auction. If the money can be handled off-site, it won't have to go through finance. It is something regarding the facilities use policy. She will know more about this in the next few days and will report back. She does not see an issue with it being approved.

Candace Marles suggested working with some of the stakeholders ahead of the meeting since there are so many band students that attend church there.

#### a. Logistics Chair STILL needed

Lisa Dumain said that she has been turned down 3 or 4 times. Mr. C said that he will be plugging this again at the concert on Monday. Candace Marles suggested asking people at the concert to talk to one of the board members and we can identify ourselves by standing up.

#### 5. Do we want to sell Band Apparel at all this year? If so, when?

The apparel site now has an online ordering option. It doesn't cost anything to facilitate this. The board agreed to do this again, and if possible, before Christmas. Mr. C will ask the company when they would need orders to have the items ready by the concert on December 19th. If enough is sold, then the band makes some of the money.

#### 6. Other Fundraiser thoughts?

#### a. Fundraiser Chair

This position is still open. The Swing Dance Chair position is more important to be filled at this time.

#### b. PayPal setup for Band Booster Donations

This has been approved by the administration. PTSO uses this platform for donations. The goal is to have this set up by next week after the concert. FansRaise takes 15% of the profit and PayPal takes 2.5%.

Also, any 501c3 can be looked up on Amazon Smile and some funds can be raised this way. It has not been set up yet, but Mr. C will look into this.

#### c. <u>Butter Braid</u>

i. Sales can be done online-sellers can accept debit and credit cards.

ii. Pastries retail for \$15.00 and profit is \$6.00. Coffee retails for \$15.00 and the profit is \$5.00.

iii. There are eight different flavors.

iv. Two-week turn around for deliveries.

DSA choirs uses this company and Candace Marles said they taste really good.

The Board agreed to try and get the donation platform off the ground first before adding another fundraising item.
